In addition, I hereby release and discharge Four Winds and its directors, officers, agents, representatives and members from any and all actions, claims or demands I, my heirs, legatees, guardians, legal representatives, or assigns now have or may hereafter have from injury or damage resulting from my participation in any and all snow sports activities, participation in any and all other Four Winds activities. If I am bringing any minor children, I agree to indemnify and hold harmless the released parties for all claims arising from injuries to my minor children.
